Sehubungan dengan rencana Perseroan untuk melakukan Penawaran Umum Obligasi Berkelanjutan ("Obligasi"), Perseroan telah melakukan beberapa perubahan yang tidak substansial terhadap catatan dalam Laporan Keuangan Perseroan Yang Diaudit per 30 Juni 2016

In relation with the Company's plan to conduct a Public Offering of Shelf Registration Bond ("IDR Bond"), the Company has made certain non-substantial revisions to the notes in the Company's Audited Financial Report 30 June 2016.

Perubahan tersebut tidak berkaitan dengan angka-angka namun hanya berkaitan dengan klarifikasi atau elaborasi atas catatan-catatan dalam Laporan Keuangan Perseroan Yang Diaudit per 30 Juni 2016 tersebut dan tidak material.

The changes do not relate to the numbers in the Financial Report 30 June 2016 but are clarifications and elaborations to the notes of the Financial Report 30 June 2016 and are not material.

Perubahan dan/atau penambahan dalam catatan adalah sebagai berikut:

The revisions and/or additions in the notes are as follows:

1. Catatan 2p Aset Tetap : penambahan tabel berkaitan dengan keterangan tentang "tarif".
2. Tambahan catatan baru, yaitu "Catatan 10 Biaya Dibayar Dimuka" yang menjelaskan rincian atas Biaya Dibayar Dimuka.
3. Karena penambahan catatan pada "Catatan 10", maka penomoran seluruh catatan menjadi berubah.
4. Catatan 13 Aset Tetap (semula "Catatan 12"): penambahan kalimat berkaitan dengan keterangan mengenai anak-anak perusahaan yang telah lengkap revaluasinya dari DirJen Pajak.
1. Note 2p Property, Plan and Equipment : a table providing the applicable tariff rates was added.
2. "Note 10 Prepaid Expenses" was added to provide a breakdown of Prepaid Expenses.
3. As a consequence of the addition of the new Note 10 above, all subsequent notes were re-numbered.
4. Note 13 (formerly Note 12) Property, Plant and Equipment: the subsidiaries for which revaluation by the Directorate General of Taxation has been completed were listed.
